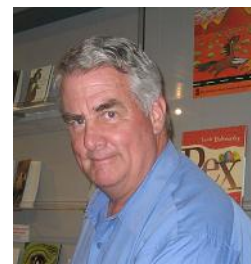

Author of a number of award-winning books on Western Australian history, Jenny's latest is a *City of Light: A history of Perth since the fifties* (2003). She is editor in chief of the *Historical Encyclopaedia of Western Australia*, forthcoming 2008, and is also working on a book on relocated buildings.

Jenny is a member of AHA, PHA, RWAHS, OHAA, NT, ICOMOS, fellow of RHS, President, National Trust of Australia (WA) and a Director, WA History Foundation. In 2001 she was awarded a Centenary Medal for her distinguished work with the National Trust and in 2004 a Champion Award by the Year of the Built Environment. In August 2006 she was an invited participant in the Federal Government's Australian History Summit.

She was active in the formation of the History Council of WA, chairing the initial Working Party and Steering Committee, and became the inaugural President, retiring in September 2007.

Dr Bill Leadbetter

Bill is currently the Senior Policy Adviser to the Minister for Heritage. He is on secondment from Edith Cowan University where he has held positions lecturing in History and Education. Bill was trained as an Ancient Historian at Macquarie University and has published widely in the history of the Later Roman Empire and taken part in archaeological surveys of Roman sites in Turkey. More recently, Bill has been working on the policy and pedagogy of History Education.

He is a vigorous proponent of the teaching of History in Primary and Middle Schools. In 2006, Bill was awarded a Carrick Award for Excellence in University Teaching and Learning. In 2007, he chaired the ARM Panel which separated Modern History from Ancient History and re-established them as distinct options for TEE study.

“The Economics of Heritage Preservation” lecture, held on 25 October 2007 for the History Council of WA.

History Council members were invited to a presentation by visiting American specialist Donovan D. Rypkema on understanding heritage from an economic point of view.

It was held at the National Trust's Old Observatory in West Perth, and began promptly at the advertised starting time of 5pm. The event was also open to the Museums Australia (WA) society, and more than 20 people attended.

History Council Treasurer Robert Mitchell introduced the speaker. Donovan D. Rypkema, an American, is the president of Washington-based company Heritage Strategies International. HSI advises on broad range of clients on handling the economic aspects of preserving, restoring and re-using heritage buildings and surrounds.

Donovan spoke for over an hour, and addressed numerous issues. He quickly established a connection with the audience, and held their concentration throughout the speech.

Donovan was a vigorous, humorous and clear speaker, and his PowerPoint presentation featured many photos and graphs. He supported his statements with statistics: The audience was particularly intrigued by the demographic diversity that corresponds with a historic district (for example in Philadelphia and Cleveland).

Donovan's lecture covered the intersection of real estate and culture, where development motives traditionally oppose the public good. Yet his research demonstrated the increase in values gained by heritage expenditure – for instance, properties in Texas in a designated historic zone were appraised at 5 to 20% more (such escalation was also true for the UK and South Africa). He proved the worthwhile nature of restoration to the economy, citing jobs created and the increase in the number of tourists.

He received enthusiastic and sustained applause, and numerous questions followed. Donovan then generously offered to continue discussions during the refreshments. The guests adjourned to a nearby room, and enjoyed wine, fruit and cheese platters while socialising.

Meetings of the Committee

The Committee meetings held on 24 October 2007 included the following business items:

- The recently elected president Sue Graham- Taylor welcomed new members of the committee, who at the same time were presented with starter CDs explaining the role of the History Council.
- The committee considered it imperative that a History Council representative should continue to serve on the Premier's Book Awards in the category of history.
- Committee members moved that a letter be sent to the Minister for State Development, Mr Eric Ripper, requesting that any company or State entity which intends to pursue development in the Kimberleys needs to put aside sufficient funds to undertake a compulsory archaeological survey of both European and Indigenous heritage. Copies were also to be sent to local Members.
- In order to plan coming events for 2008 the Communications Committee intend to meet on 16 January. Council is presently seeking a new chair for the sub-committee.
- Following the resignation of Jenny Edgecombe from the Committee Jennie Carter has agreed to represent the History Council at the National Archives of Australia (WA) Consultative Forum.

2007 Celebrate WA Week 14-21 October

WA Week was first celebrated in 1973, to promote the history, achievements and possibilities in our state, and foster civic pride. WA Week's current placement in October (initially it was in June) is to tie in with Proclamation Day – this marks 21 October 1890, when the new Constitution enabling self government for Western Australia was formally declared by Governor Sir William Robinson.

This year the History Council's Ruth Marchant James was on the steering committee. They achieved an excellent and diverse program, with exhibits and open days held, such as at the Medical Museum. Both free and ticketed events were offered, and History Council members could obtain discounted entrance to the Oral History Association's annual conference at the State Library during the first weekend. The official opening of the 2007 Celebrate WA Week was conducted in Kings Park on Monday 15 October, by His Excellency Ken Michael, who arrived in a horse-drawn carriage!

This year the History Council's Ruth Marchant James was on the steering committee. They achieved an excellent and diverse program, with exhibits and open days held, such as at the Medical Museum in Subiaco and at the Nedlands Croquet Club. Rural locations also participated, with Toodyay having a week-long town quiz, and Hyden Progress Association holding a party. Both free and ticketed events were offered, and History Council members could obtain discounted entrance to the Oral History Association's annual conference at the State Library during the first weekend.

The official opening of the 2007 Celebrate WA Week was conducted in King's Park on Monday 15 October, by His Excellency Ken Michael, who also closed festivities a week later in the grounds of Government House.

New High School History Syllabus

On 2 October the Federal Government released a high school syllabus for the teaching of Australian history. This 20 page guide facilitates the introduction of 150 hours of compulsory education. Nine topics were recommended, such as *First People*, *British Colonies* and *World War 2*, and over 70 milestone events and 100 people were to be learnt. The national curriculum is to be supplemented by each State's particular history: Prominent West Australians have suggested our schools include Dutch exploration, the gold rush and the WA Inc scandal.

The launch of the guide has been met with some criticism – for example, History Council Past President Jenny Gregory identified the lack of female and ethnic representation. Meanwhile, Tom Lobreck from the WA History Teachers Association stated that the syllabus was too crowded, which would cause rushed instruction. Also, objections have been raised that the delivery of the subjects is in return for Federal funds.

Yet overall the strong cross-sectoral support for a return to the teaching of Australia's past means its implementation is highly likely.

Switched On! Presentation on The East Perth Power Station History Project

On Thursday 18 October Murdoch University's Associate Professor Lenore Layman spoke on the East Perth Power Station History project. Approximately 20 people attended the event, which began in the State Library's Great Southern Room at 12.30pm. The presentation was co-run by the State Records Office (as part of their ongoing series of lunchtime seminars) and Celebrate WA Week, and the organisers generously offered refreshments.

Professor Layman emphasised the relevance of the topic, not only with the looming energy crisis but the upcoming decision as to the future use of the site. She noted the national as well as local significance of the East Perth building, with it not only being the first centralised power station in Australia, but until 1951 the only one in our state. She detailed the three generations of the site, from 1915 until 1981, and provided many facts, such as its critical role in World War 2, and the prestigious Turbine 6 not being taken offline for years. Professor Layman also covered her personal research techniques, and explained the various records that she had used. These spanned Western Power's files, personnel data, photographs, and technical manuals, and the oral histories of the workers and the users that had been compiled.

The project team will produce audio tapes, a book and a website. The themes that structure the project are the democratisation of memory, with the numerous contributions and interpretations possible, and the effects of commemorations on the living. Excellent progress has been made, with already 157 hours of interviews captured, and chapters for the book will address the perceptions and people of the area (including indigenous occupation), its growth and decline, the environmental impact of the station, and its role in our city. Professor Layman is especially keen on the website, to be multi-media with content like the hum of the machines!

Professor Layman concluded by urging the prioritisation of history in general, as well as recognition of the value of the East Perth Power Station project. She then took questions from the audience, whose enthusiasm prolonged the event.

Did you know?

Dates in WA history.

90 years since first WA policewomen began

October marked the 90th anniversary of the first commissioning of Western Australian policewomen. (Some states such as New South Wales and South Australia had recruited policewomen 2 years earlier). In Perth, Mrs Helen Blanche Dugdale and Miss Laura Ethel Chipper commenced patrol walks in 1917, though the scope of duties they were assigned were limited by the authorities due to their sex. Consequently, the female constables addressed the welfare of women and children, and mostly handled the victims and offenders of prostitution, truancy, delinquency, and also investigated missing persons.

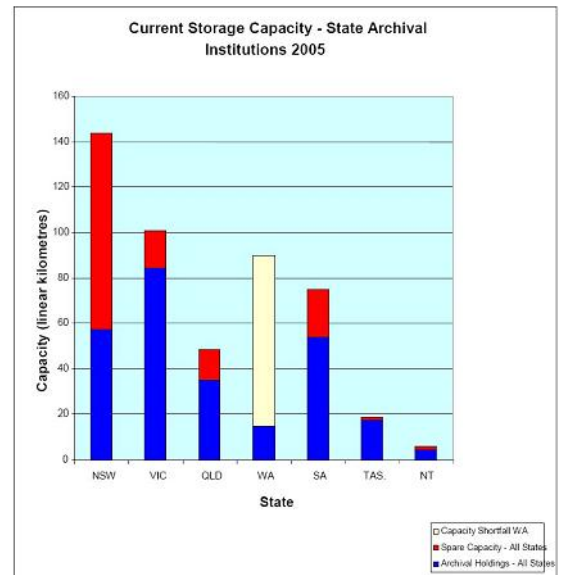

Delegation to Premier's office

On Thursday 22 November President Sue Graham-Taylor and Councillor Jennie Carter, attended a meeting with a senior staff member of the Premier's office to discuss the letter sent by the History Council to the Premier. The letter expressed our concerns about the lack of space to store State Government records and the failure of the Government to act upon what is now becoming a dire situation. Premier Carpenter was asked to "accept the urgency of this situation and take steps to provide for an improved Archives Repository". A graph showing the current storage capacity of all State archives in Australia accompanied the letter and is reproduced here:



Sue and Jennie were given a sympathetic hearing, but no commitments or undertakings to resolve the issue were given at the meeting. Sue stressed that the Government is wholly accountable for the safety, suitable management and accessibility of the archival records of all State agencies. As it stands at present, those records which cannot be taken into State Records Office care remain vulnerable to loss, destruction, and damage. The recent Esperance floods was an extreme example, but highlighted the potential danger to irreplaceable records. Poor environmental conditions in some regional areas is also an issue.

The Premier's senior officer did agree that the lack of suitable archive storage in WA needed to be addressed. He added that building an archive repository would be a major and expensive undertaking but understood that one would have to be provided at some time in the future. He will brief the Premier and ensure a response is given to the History Council's concerns.
